A manager referred to in section 24(4)(b) shall, subject to the provisions of section 32(7) represent a corporation at such enquiry and is personally responsible, irrespective of any responsibility of the corporation, for any act or omission by or on behalf of a corporation which may result in disciplinary action by the council, **unless the council is satisfied that the responsibility for that act or omission rests upon another person who is registered in terms of the Act and is a member or employee of that corporation.**
